Terms and Conditions

1. Definitions:
 - 1.1. **TBKD** shall mean Triangle Bushin Kan Dojo, Incorporated as well as the director, officials, instructors, and sponsors of this organization.
 - 1.2. **TBKD and Affiliates** shall mean TBKD; Dai Nippon Butoku Kai (DNBK) of Japan, USA, and International Divisions; the East Coast Karate Association (ECKA); the Japan Education Culture Center (JECC); all satellite dojos directly associated with USA Dai Nippon Butoku Kai Bushin Kan Dojo; as well as the directors, officials, instructors, and sponsors of these organizations.
 - 1.3. **Member** includes the applicant or the applicant's parent or guardian if the applicant is a minor.
 - 1.4. **Training Program** includes attendance and/or participation in any instruction class, training session, demonstration, seminar, competition, and any other sanctioned event held or sponsored by TBKD and Affiliates.
 - 1.5. **Membership** in TBKD shall allow all Members to participate in the Training Program. Membership in TBKD does not automatically extend to membership in affiliated organizations defined as TBKD and Affiliates.
2. **WAIVER OF LIABILITY:**
 - 2.1. Member fully understands that this is an activity which involves physical exertion and physical contact. Member **consents to such contact and is fully aware of the possible risk of injury.**
 - 2.2. It is expressly agreed that all activities and use of facilities shall be undertaken at member's sole risk and that TBKD and Affiliates **shall not be liable for any claims, injuries, damages, or cause of action whatsoever, to person or property** while participating in the Training Program.
 - 2.3. **MEMBER ASSUMES FULL LIABILITY FOR ALL INJURIES OR LOSSES.**
 - 2.4. Member does hereby expressly forever **release and discharge** TBKD and Affiliates from all liability for all injuries or losses that may occur as a result of participation in the Training Program.
 - 2.5. Member agrees to **fully indemnify** TBKD and Affiliates for any expenses incurred in any litigation arising out of participation in the Training Program. This includes, but is not limited to, all medical fees and legal expenses arising out of such action. If member breaches this agreement, he/she shall be responsible for all legal fees and court costs incurred by TBKD and Affiliates.
3. Medical:
 - 3.1. Member **warrants that he/she is in good health** and suffers from no illness or condition that in any way prevents him/her from carrying out the physical program provided by TBKD and Affiliates.
 - 3.2. Member attests that **he/she suffers from no condition, illness, or communicable disease** which in any way could possibly be infectious to others.
 - 3.3. No member shall use the facilities or participate in class with any open cuts, abrasions, open sores, infection or maladies so as not to pose a potential threat to others.
4. Late or Return Item Charges:
 - 4.1. **A \$10.00 LATE FEE WILL BE AUTOMATICALLY ASSESSED TO ALL ACCOUNTS IN WHICH PAYMENT IS NOT RECEIVED BY THE 5TH DAY AFTER THE DUE DATE.**
 - 4.2. **ALL RETURNED CHECKS WILL BE CHARGED A \$25.00 FEE.**
5. Default/Collection:
 - 5.1. If payment is not received within 5 days of the due date the member shall be considered to be in default and the member may be restricted from the Training Program until all financial obligations are paid.
 - 5.2. TBKD and Affiliates may at its option delay or waive enforcement of any of its rights under this agreement without losing them.

6. Involuntary Resignation:
 - 6.1. It is understood and agreed that TBKD reserves the right to terminate any membership from the Training Program for any reason and at any time. The terminated member waives any right of protest or return of any fees paid.
 - 6.2. The terminated member will remain liable for any incurred indebtedness.
 - 6.3. Involuntary Resignation from TBKD does not automatically terminate membership to organizations defined as TBKD and Affiliates. Resignation of any membership in those organizations shall be specifically defined by those organizations.
7. Voluntary Resignation:
 - 7.1. The Member may terminate this agreement in the following ways:
 - 7.1.1. Written notice to TBKD.
 - 7.1.2. Extended non-attendance; failure to attend any classes for more than thirty (30) days without prior written notice to TBKD will be deemed voluntary resignation.
 - 7.1.3. Invoking Buyers Right to Cancel; The buyer may give written notice to TBKD within three (3) days after signing the agreement to fully cancel all agreements set forth within and be entitled to a full refund of any membership fees paid.
 - 7.2. Voluntary Resignation from TBKD does not automatically terminate membership to organizations defined as affiliates of TBKD. Resignation of any membership in those organizations shall be specifically defined by those organizations.
8. Leave of Absence:
 - 8.1. Members may apply for a leave of absence to defer invoking the Voluntary Resignation policy. Acceptance of the Leave of Absence application will be determined solely by TBKD.
9. Membership Fee
 - 9.1. A membership fee will be incurred after a reasonable initial introduction period.
 - 9.2. The membership fee is due at the beginning of the Membership Term.
 - 9.3. The membership fee is separate from any other fees associated with this agreement.
 - 9.4. The membership fee is **non-refundable** in part or full three (3) days after signing the Membership Agreement.
10. This agreement is the final and complete expression of the terms of membership. No additional written or oral terms may be added to supplement, explain, or contradict the terms of this membership. All prior agreements between member and TBKD are void.
